- \* Due to the nature of the labor-management agreement, the above activities are "unpaid" from the viewpoint of restrictions on conflicts of interest.

### [Term of office of employee representative]

Two years from July 1, 2022 to June 30, 2024

\* If the employee representative retires during the term of office, a new employee representative will be elected, but the term of office

Will be up to the term of the predecessor employee representative.

\* If the employment contract with our company is terminated, the employee representative will also be dismissed on the termination date.
